Emergency Support Function #6 Review:

ESF #6 is Coordinated by the Harvey County Health Department. ESF #6: Mass Care, Emergency Assistance, Temporary Housing and Human Services and one of fifteen Emergency Support Functions encompassed in the Harvey County Emergency Operation Plan(EOP). The EOP was approved by both Kansas Division of Emergency Management and the Harvey County Board of County Commissioners through August of 2025.

ESF #6 assists both people and animals for short and long term sheltering. This involves working with local, state and at time federal entities to assist with sheltering, providing aide, food, mental health support and a variety of other facets to assist those in need. Partnerships throughout Harvey County can assist with identifying those with critical needs who may not other wise be able to help themselves.

LEPC Partners stated their respective entities may be able to assist with ESF #6 by offering the following:

- -Newton Public Library—dispensing supplies.
- -Newton City County Airport-Air Operations, staging/storing and potential freezer storage with other business support
- -Prairie View- Mental Health Support, Vans for Transportation, large rooms for use
- -NMC Health- medical treatment, a large cafeteria to provide food, additional medical equipment(Healthcare Coaltion equipment).
- -Harvey County Health Department—stressed the utilization of 211 via the United Way.
