Full or first half payments may be made thru December 20 and last half payments until May 10. Statements in the amount of \$1 0.00 or less must be paid in full. First half taxes become delinquent December 21 and last half taxes become delinquent May 11. If no payment is made on personal taxes by December 21 the total tax becomes delinquent and accumulates interest to the date of payment. Delinquent taxes draw interest in the following amounts:

Late payment of real or personal property taxes	7%
Late or underpayment of \$10,000 or more	12%
Late unpaid portion of advanced payments	5%
